Public Forum:

Joel Thompson: The catch basin was moved from near the telephone pole and put closer to the corner of S. 2nd St. It is currently at the highest point on that property, which is causing it not to catch the water. The property is continuously flooding. 217 says they aren't going to move this catch basin because the catch basin is supposed to catch the load and not all of the water. Joel contacted a landscaper who said he would grate it so it slopes. They quoted this project at \$2,000. Once the landscaper finishes, Joel would then call 217 back to lower the basin.
